in materia di sequestro, confisca, gestione ed alienazione dei beni nella disponibilità di appartenenti ad organizzazioni mafiose, introdotte dalla “legge di stabilità” del 2012; la nuova disciplina della certificazione di qualificazione energetica degli immobili e quella delle aree destinate a parcheggio; le disposizioni sulle tariffe notarili di cui al decreto ministeriale 3 agosto 2013 n. 106 e sulla rideterminazione dell’ambito territoriale di attività dei Notai; il recepimento delle direttive sul titolo esecutivo europeo.
